## The TD test will be limited to 2 dogs.

Entries with valid Certification will be accepted until 5:00PM, March 27, 2019. In drawing for TD entries and alternates, dogs not holding a TD title will be given preference over those who have a TD title. When a limit of 2 TD entries has been reached, the draw will continue and an alternate list established.

### The TDX test will be limited to 4 dogs.

Entries with an AKC TD will be accepted until 5:00PM, March 27, 2019. When the limit of 4 TDX entries has been reached, the draw will continue and an alternate list established.

The 2 TD and 4 TDX entries will be selected at the SJDTC training site, Sycamore Lane Kennels, 5111 W. Sargent Road, Lodi CA 95242 at 6:00PM Wednesday, March 27, 2019.

**Exchange of Tracks:** If the limit for entries is not reached in one test and the limit for entries is exceeded in the other test, the number of tracks may be exchanged on the basis of 2 TD tracks for 1 TDX track.

Notification of the draw results will be mailed as soon as possible after the entries have closed and the draws have been conducted.

Overnight and Express Mail entries must specify "no signature required".

**TD** and **TDX** Awards – A plaque will be presented to each dog passing at these tests. Plaques have been made and donated by Bill Anderson. Photos will be mailed.

# This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Entry fees will be refunded if the dog has passed a Test after the entries have closed, the entrant notifies the Secretary 48 hours prior to the Test and an alternate runs the track. Entry fees will also be refunded for an alternate who does not run or for a dog with a medical condition which prevents participation provided the request is received before the drawing for tracks and is accompanied by a Veterinarian's statement. Fees returned after the Tests.

Drawing for the TD Test tracks will be at the test site at 7:30AM and the drawing for the TDX Test tracks will be at 9:00AM. Judging will begin as soon as the tracks have aged sufficiently. Entrants and their dogs not present at the time of their draw will be marked absent and an alternate will run in their place.

Bitches in season may participate in these Tests. If your bitch is in season, park your vehicle well away from the Test site, keep bitches in season away from other entered dogs and notify the Test Secretary. If there is more than one bitch in season a second draw will be held for those bitches. Bitches in season will only be allowed to participate after all other dogs have been tested. Failure to comply will result in the dog & handler being excused from the Test site and any award withheld.

The Camanche Hills Hunting Preserve is NOT available for practice before the Tests.

Dogs must be on leash at all times. Failure to comply will result in the dog and handler being excused from the test site and withholding of any awards.

Morning and After Test hospitality will be provided by the SJDTC.
