If you are entered in a class that includes a jump, you must specify your dog's jump height on the entry form.

Illegible entries will not be processed and will be returned to the exhibitor or shredded. Print or type entries carefully, using BLACK or BLUE ink. The Club accepts no responsibility for incorrect or illegible entries. Entries that are received unsigned, without the proper entry fee or without both sides of the form, will not be accepted.

Acknowledgement of receipt of entries will be made soon after closing date. Confirmations and judging schedule will be sent by email only, so please include your email address on your entry form. Should such acknowledgement of receipt of entry not be received by an exhibitor five days prior to the trial, please contact the Trial Secretary. No entries can be changed or refunded after the closing date.

Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date (except for waitlist provisions), nor in the event a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances, fire, act of God, act of a public enemy, strikes, extreme weather conditions (including, but not limited to, extreme heat, snowstorms, or hurricanes) or any other act beyond the control of the management it is impossible to open or to complete the Trial, no refund of entry fee will be made.

Returned checks do not constitute a valid entry and the Trial Secretary will add a \$35.00 collection fee to the amount of each returned check.

Bitches in season: Full refund will be given for bitches in Season after the closing date. You must request a refund in writing to receive a refund. The request must be received by the Trial Secretary no later than 30 minutes prior to the start of judging.

Wait List - SJDC is offering a wait list to fill openings created by withdrawn entries prior to the trial's closing date/time. A maximum of **15 entries** will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to the trial's closing date/time. No entries may be withdrawn with a refund after the trial's closing date/time. If a withdrawn entry is replaced by a wait listed entry, the original entry and check will be shredded. Any wait listed entry that does not move off the wait list into the trial will have the original entry and check shredded.

Move-ups: Move-ups will be allowed at these trials per AKC Regulations.

In the case of a tie for an award, a dog that is not present for a run-off will forfeit the right to the award.

Ribbons: No Ribbons will be mailed.

Catalog Order: As far as is practical, all entries will be arranged according to jump height, for all rally classes that require jumps.

Rally Maps will be emailed after 6:00PM on the day before the trial. Maps will be posted at the site as well. Printed maps will not be distributed at the trial.

GROUND RULES AND TRIAL PROCEDURES

Crating will be allowed in the building.

- Please put a **CLEAN** towel or mat under your **CHAIR and CRATE** to protect the matted surface.
- NO X-pens in the building.
- NO crate aggressive dogs in the building.
- A dog not entered in the trial is not allowed in the building.

NO overnight & NO day of RV parking.

NO smoking allowed on the grounds.

You will not be allowed to leave your vehicle idling in the parking area.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Every precaution for the safety of dogs and exhibitors will be exercised, but neither the Club nor the management will be responsible for loss or injury.

Only dogs that are eligible to be shown under AKC rules shall be allowed within the show precincts.

All dogs must be **ON-LEASH** at all times while on show grounds and parking areas unless in the ring for judging.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Consult the judging schedule for the time of judging. Exhibitors and handlers are responsible for the presence of their dogs in the judging ring. The Club assumes no responsibility for this.
