PROGRAM OF JUDGING

Dogs may arrive at any time prior to scheduled judging. The owner/ handler of each dog is solely responsible for having it ready at ringside when it is to be judged. Judges are not required to wait for any dog. Dogs not required for further judging may depart the grounds at owner/ handler discretion. All dogs must be held on leash or confined to their crates or x-pens except when being judged. No practicing allowed in the rings at any time. Judges will take breaks for rest or meals at their discretion.

All classes with walkthroughs, will have A and B combined walkthroughs. (Novice A & Pref Nov will have a combined walkthrough) **Time listed is the start time for the walk through.**

DIRECTIONS TO TRIAL SITE:

FROM I-5: Take Hwy 12 East (Exit 485) toward Lodi, for 1.6 miles, to Ray Rd. Turn left on Ray Rd. Proceed for 1 mile to curve in road, turn left and follow signs to Sycamore Lane Kennels.

FROM HWY 99: Take Hwy 12 West (Kettleman Lane) toward Lodi. Go through Lodi about 5 miles to Ray Rd and turn right. Proceed for 1 mile to curve in road, turn left and follow signs to Sycamore Lane Kennels.

OBEDIENCE AND RALLY MOVE-UPS to the next level are allowed for dogs completing a title after close of entries. The request must be made **IN WRITING** at least 30 minutes prior to judging. Please inform the Trial Secretary **AS SOON AS POSSIBLE** if you wish to move your dog to the next level class. Move-ups will run at the end of the class (or with their rally jump height if possible).

PARKING IN DESIGNATED AREAS ONLY. There will be a **\$5 charge collected for daily parking by Sycamore Lane Kennels.** No parking allowed near the Grooming or Training building. Everyone must park in the large parking lot east of the big lawn unless they have a handicap placard. Unloading is allowed near the entrance to the arena or near the training building, but vehicles must be moved after unloading. Cost is **\$35 for overnight RV camping**, no hookups. DO NOT ALLOW DOGS TO POTTY NEAR THE VINEYARDS. Use gravel areas, or the grass area around the big tree in the parking lot. Do not take your dogs with you to the restrooms or anywhere near the kennels.
