
# San Joaquin Dog Training Club September 12,13,15, 2024 - Scent trial

## 185 People – 228 dogs – 1136 runs Thursday 123 runs, Friday #1 339 runs, Friday #2 216 runs, Sunday 458 runs



**Waitlist:** There is only a waitlist for the Detective class. If you cannot make the trials, you will be marked absent. No bitches in season are allowed, refunds will be given for bitches in season if you contact the secretary 30 minutes before the trial starts. Text 916-947-6823 with Call name, Armband #.

**\*SPECTATOR** may be allowed in the search area. This is left up to the judge. Spectator must have already run in the class if entered.

### Don't Ask, Don't Tell!

Remember that after you run you cannot talk with anyone about the test/class until it is over. When you ask someone how they did, you can only ask by showing a thumbs up or thumbs down, do not ask! If you are asked how you did, you can ONLY give a thumbs up or thumbs down, you cannot talk about how your dog did to anyone (in person or on the phone). People can overhear which is not fair to them.

Refer to the AKC regulations if you have any questions.

**Videoing and Pictures:** You can video or take pictures of your runs and/or search area. They cannot be posted or shared until the trial is over.

**Reactive and aggressive dogs:** Please refer to the AKC regulations on reactive/aggressive dogs. Per AKC regulations no special accommodations will be made for reactive/aggressive dogs. **Please note** if you cannot control your dog, you will be asked to leave (no refund). If your dog attacks another dog or person, you will be disqualified from all AKC events in the future with that dog.

#### Parking: Follow the signs or person directing you.

• Bring your own shade cloth, and water for you and your dogs. Out of courtesy for others (and pursuant to California law), please do not leave cars running in parking area.

Please, pick up after your dogs. No exceptions

#### Schedule

\*Run orders will be posted at check-in, please make sure you check-in under each judge. \*Ask where you can walk, do not enter the testing areas unless it is your turn to run. \*Conflicts: You must check-in before your class starts if you are going to have a conflict with other events. If you have a conflict with another event you might have to run early in order to not miss your scent run, be prepared to do so. Please do not come over and say I need to run now, you must tell the check-in people if you have a conflict before the class starts in order for them to fit you in. \*Lunch breaks have been built into the schedule but if we are running late each judge will take a 45 minute to 1 hours lunch break.

\*What does to follow mean: it either means one class will finish completely and then the other class will start (you get in line twice). Or the classes will run back to back; you run in one class and then run in the other if you are in both (you get in line once).

\*Briefing times are noted below: If you miss the briefing you will be briefed by the start line for each class. For classes without a briefing time list, you will be briefed by the start line for each class.

\*Schedule does not take into consideration withdraws or move ups.


