Exchange of Tracks: SJDTC is implementing the 'AKC Rule: Chapter 1, Section 17a. Combined Tests Exchange Policy'

Test Worker Option: SJDTC is participating in the 'AKC Rule: Chapter 1, Section 17d Test Worker Option'.

SJDTC is setting aside one (1) TDX track in this test for test workers. In the event the TDX test does not fill by close of entries, TDX tracks will be exchanged for TD tracks on a two (2) TD tracks to one (1) TDX track basis. If this happens, and the number of TDX tracks available decreases to three (3) and TD tracks available increases to four (4), then one (1) TD track will be set aside in the TD test for test workers, and one (1) TDX track will be set aside in the TDX test for test workers.
